Admission Information Handout

- 1) **Program** : **B.Sc. (Hons.) Agriculture.**
- 2) **Student Intake** : **will be updated at the time of admission**
- 3) **Duration of the course** : **Four (4) years**
- 4) **Eligibility Criteria (fulfilling all/applicable conditions mandatory)**
 - 4.1 A candidate must have passed 10+2 or Equivalent Examination and must have obtained a minimum of 50% aggregate marks with PCM/PCB/PCMB (P- Physics, C- Chemistry, M- Mathematics, B- Biology) from a recognized Board/University.
 - 4.2 Candidates appearing for their final 10+2 or equivalent examination can also apply provide they meet minimum cut-off marks and produce all the necessary documents, in original, at the time of admission. The 10+2 or equivalent examination should have been conducted before the course commencement date.
 - 4.3 Candidates from CBSE & ICSE should mention in the registration form, 10+2 or equivalent aggregate marks of all the subjects which the candidate has taken and passed (not best of four, five, six or seven). The candidate shall have passed all the subjects taken and appeared for in the applicable examination/s.
 - 4.4 In case, the mark sheet issued by the applicable Board/University is in percentile/s, the actual aggregate percentage of all the subjects studied and examination taken by the candidate will be considered for confirming eligibility of the candidate for the program.
Mark sheet/transcript issued by Board/University only will be considered (Marks sheet/transcript issued by the School/Institute will not be accepted).
 - 4.5 Those candidates who have either passed or are appearing for 10+2 examination from a Board/University where Grade Point Average is given, must produce in writing from the concerned Board/University about the equivalent percentage for the GPA/ CGPA obtained.
 - 4.6 Candidates above **25 years** of age are not eligible to apply.
 - 4.7 Only Single mark sheet with all compulsory subjects taken and passed will be considered. Compartmentalized mark sheet will not be considered.
 - 4.8 At any stage, if it is found that the 10 + 2 marks given by candidate in application form is different from marks actually obtained (as per mark sheet), such candidate's admission will be cancelled and fees will be forfeited.
 - 4.9 Candidate whose final mark sheet is not available at the time of admission are required to upload internet copy of result or Digi locker copy of result, duly attested by Principal of the school/college, failing which the candidate will not be admitted for the program.

- 4.10 Candidate will not be eligible if any subject is marked as 'Ungraded/Fail' in the mark sheet/ grade sheet. However, 'absent /ungraded' marking in any of the additional/non mandatory subject will be considered as eligible, provided such candidate is declared as pass by respective board.
- 4.11 It is the sole responsibility of the candidate to ascertain whether they possess necessary and requisite qualification for admission to the courses at NMIMS.

5) Online Registration & Payment of Registration:

Online registration fee of Rs. 2000/- plus applicable taxes (Please refer online registration for payment details.)

Registration fee is non-refundable.

6) Selection Process

1. Merit list will be prepared on the basis of 12th aggregate percentage provided by the candidate at the time of registration.
2. The merit list will be put up on the NMIMS website as per important dates. The decision of the institute will be final in this regard and no inquiries or correspondence in this regard will be entertained.
3. Once the merit list is declared, candidate has to login to check result on NMIMS portal using his/her credentials. Admission offer is given as per merit and vacancy. Selected candidates should proceed to submit the document and make the fee payment within the stipulated time line as mentioned in the offer letter.
4. Waitlisted candidates have to check their merit list status regularly as per important dates.

7) Program Fees: (Subject to change)

- Program fees for 1st year B.Sc. (Hons.) Agriculture academic batch 2023-2027 was Rs.1,25,000/- per annum.
- Program fees for 1st year B.Sc. (Hons.) Agriculture academic batch 2024-2028 will be announced at the time of admission.

8) Important instructions:

- Cancellation / withdrawal of admission:

Withdrawal/cancellation means voluntary withdrawal/cancellation by candidate for any reason. Please use the below link <https://upload.nmims.edu/admission/cancellation/> for admission cancellation form.

Candidate has to upload duly filled in and signed cancellation form along with fees paid receipt copy and cancelled cheque (personal account).

- Please see the important dates and preserve it as a guide.
- All announcements from the institute will be through its website: www.agriculture.nmims.edu and no individual communication will be sent to the candidates.

- Admission to program is considered as “Provisional” till all required and mandatory documents are submitted by the candidate and the same is verified and approved. If it is found that the candidate is not eligible at any stage (even after the course commencement), admission will be cancelled and fees will be refunded as per refund rule clauses even if selected/admitted to the program.
- If at any stage, it is found that a candidate does not satisfy the eligibility criteria or the information furnished by him/her in the application form is incorrect, his/her admission to the course, even if selected/admitted, will stand cancelled.
- NMIMS has full right to disqualify a candidate at any stage of admission process, if found ineligible. No separate intimation will be given.
- Canvassing in any form for admission will disqualify the candidate.
