Refund Rules:

If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees remitted by the student.

Sr. No.	Percentage of Refund of Aggregate fees	Point of time when notice of withdrawal of admission is served to HEI
1	100%	15 days or more before the formally-Notified Last Date of Admission (on or before 20th Oct., 2021)
2	90%	Less than 15 days before the formally-Notified Last Date of Admission (i.e., from 21st Oct., 2021 to 5th Nov., 2021)
3	80%	15 days or less after the formally-Notified Last Date of Admission (i.e., from 6th Nov., 2021 to 20th Nov., 2021)
4	50%	30 days or less, but more than 15 days, After Formally-Notified Last Date of Admission (i.e., 21st Nov., 2021 to 5th Dec., 2021)
5	00%	More than 30 days after Formally-Notified Last Date of Admission (i.e., after 6th Dec., 2021)

In case of (1) in the table above, the deduction will be 5% of the fees paid as processing charges from the refundable amount, subject to a maximum of Rs 5,000/-.

1. The above refund rules are as per University Grant Commission (UGC) notification on Refund of fees and Non – Retention of Original Certificate.
