

Admission Information Handout

Bachelor of Science in Agriculture (Honors) Batch – 2022.

- 1) **Program** : **B.Sc. (Hons.) Agriculture.**
- 2) **Student Intake** : **60 Seats**
- 3) **Duration of the course** : **Four (4) years**
- 4) **Eligibility Criteria (fulfilling all / applicable conditions mandatory)**
 - 4.1 A candidate must have passed 10+2 or Equivalent Examination and must have obtained a minimum of 50% aggregate marks with PCM/PCB/PCMB or Agriculture (P- Physics, C-Chemistry, M-Mathematics, B-Biology) from a recognized Board/ University.
 - 4.2 Candidates appearing for their final 10+2 or equivalent examination can also apply provided they meet minimum cut-off marks and produce all the necessary documents, in original, at the time of admission.
 - 4.3 Candidates from CBSE & ICSE should mention in the registration form, 10+2 or equivalent aggregate marks of all the subjects which the candidate has taken and passed (not best of four, five, six or seven). The candidate shall have passed all the subjects taken and appeared for in the applicable examination/s.
 - 4.4 In case, the mark sheet issued by the applicable Board / Institution is in percentile/s, the actual aggregate percentage of all the subjects studied and examination taken by the candidate will be considered for confirming eligibility of the candidate for the program.

Mark sheet/transcript issued by Board/ University only will be considered. (Marks sheet/transcript issued by the School/Institute will not be accepted)
 - 4.5 Those candidates who have passed, or, are appearing for 10+2 examination from a Board / University where Grade Point Average is given, must produce in writing from the concerned Board / University about the equivalent percentage for the GPA/ CGPA obtained.
 - 4.6 Candidates above **25 years** of age are not eligible to apply.
 - 4.7 Only Single mark sheet with all compulsory subjects taken and passed will be considered. Compartmentalized mark sheet will not be considered.
 - 4.8 In any stage, if it is found that, the 10 + 2 marks given by candidate in application form is different from marks actually obtained (as per mark sheet), such candidate's admission will be cancelled & fees will be forfeited.

- 4.9 Candidate whose final mark sheet is not available at the time of admission are required to upload internet copy of result or Digi locker copy of result, duly attested by Principal of the school/ college, failing which the candidate will not be admitted for the program.
- 4.10 Candidate will not be eligible if any subject is marked as 'Ungraded / Fail' in the mark sheet / grade sheet. However, 'absent /ungraded' marking in any of the additional/non mandatory subject will be considered as eligible, provided such candidate is declared as pass by respective board.
- 4.11 It is the sole responsibility of the candidate to ascertain whether they possess necessary and requisite qualification for admission to courses at NMIMS.

Online Registration Fee of Rs. 2000/- plus applicable taxes (Please refer online registration for payment details.)

Registration Fee is non-refundable.

6) Selection Process

1. Merit list will be prepared on the basis of 12th aggregate percentage provided by the candidate at the time of registration.
2. The merit list will be put up on the NMIMS website as per important dates. The decision of the institute will be final in this regard and no inquiries or correspondence in this regard will be entertained.
3. Once the merit list is declared, candidate has to login to check result on NMIMS portal using his / her credentials. Admission offer is given as per merit and vacancy. Selected candidates should proceed to submit the document and make the fee payment within the stipulated time line as mentioned in the offer letter.
4. Waitlisted candidates have to check their merit list status regularly as per important dates.

7) Program Fees: (Subject to change)

- Program fees for 1st year B.Sc. Agriculture (Hons.) Batch–2021 was Rs.1,15,000/- per annum
- Program fees for 1st year B.Sc. Agriculture (Hons.) Batch–2022 will be announced at the time of admission.

8) Refund Rules: If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees remitted by the student.

Sr. No.	Percentage of Refund of Aggregate fees	Point of time when notice of withdrawal of admission is served to HEI
1	100%	15 days or more before the formally-notified last date of admission. (on or before 15th Sept., 2022).
2	90%	Less than 15 days before the formally-notified last date of admission. (i.e., from 16th Sept., 2022 to 1st Oct., 2022)
3	80%	15 days or less after the formally-notified last date of admission. (i.e., from 2nd Oct., 2022 to 16th Oct., 2022)
4	50%	30 days or less, but more than 15 days, after formally-notified last date of admission. (i.e., 17th Oct., 2022 to 31st Oct., 2022)
5	00%	More than 30 days after formally-notified last date of admission. (i.e., from 1st Nov., 2022 onwards)

In case of (1) in the table above, the deduction will be 5% of the fees paid as processing charges from the refundable amount, subject to a maximum of Rs 5,000/-.

1. The above refund rules are subject to revision as applicable.
 2. Candidates to refer important Dates of the respective programme and refer refund rules mentioned in the offer letter.

9) Important instructions:

Cancellation / withdrawal of admission:

Withdrawal / cancellation means voluntary withdrawal / cancellation by candidate for any reason. Please use the below link for admission cancellation form.
