**Refund Rules:**

If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees remitted by the student.

Sr. No.	Percentage of Refund of Aggregate fees	Point of time when notice of withdrawal of admission is served to HEI
1	100%	15 days or more before the formally-Notified Last Date of Admission <b>(on or before 12<sup>th</sup> Oct., 2022)</b>
2	90%	Less than 15 days before the formally-Notified Last Date of Admission <b>(i.e., from 13<sup>th</sup> Oct., 2022 to 28<sup>th</sup> Oct., 2022)</b>
3	80%	15 days or less after the formally-Notified Last Date of Admission <b>(i.e., from 29<sup>th</sup> Oct., 2022 to 12<sup>th</sup> Nov., 2022)</b>
4	50%	30 days or less, but more than 15 days, After Formally-Notified Last Date of Admission <b>(i.e., 13<sup>th</sup> Nov., 2022 to 27<sup>th</sup> Nov., 2022)</b>
5	00%	More than 30 days after Formally-Notified Last Date of Admission <b>(i.e., from 28<sup>th</sup> Nov., 2022 onwards)</b>

In case of (1) in the table above, the deduction will be 5% of the fees paid as processing charges from the refundable amount, subject to a maximum of Rs 5,000/-.
